Contractor management

Companies often outsource tasks like cleaning, maintenance or construction to external companies. External company and in-house employee access rights do not generally differ – however access is frequently linked to the term of a project. Kaba exos allows you to easily link access rights to a project and define the in-house point of contact. If deadlines are moved, the responsible person adjusts the access rights of all external company employees at the click of a mouse. This automatically ensures that no external persons can gain access after the project is completed.

External company employees increase the security risk because they are not familiar with customary procedures and rules. Kaba exos ensures that external company employees receive all the necessary instructions and are familiar with legal and company-specific specification before they are granted access. The system also automatically ensures that security training must be refreshed before expiry of a defined deadline. Otherwise access rights are automatically blocked. If an external company breaches your rules, you can deny access to all their employees at the click of a mouse.

Registering external companies and employees

- Administrator creates external company and employees
- Data adoption of visitors and employees if person already on record is now to be maintained as an external company employee
- Entry of external company employees according to defined process steps
- Filtering of external companies and employees per sites

Time and attendance data evaluation

Security function
